Dear Reader:

Enclosed is the Northwest Colorado Sub-regional Greater Sage-Grouse (GRSG) Proposed Land Use Plan Amendment (Proposed LUPA) and Final Environmental Impact Statement (FEIS), one of 15 sub-regional efforts being conducted as part of the Bureau of Land Management (BLM) and Forest Service National Greater-Sage Planning Strategy. The BLM and Forest Service prepared the Proposed LUPA/FEIS in consultation with cooperating agencies, taking into account public comments received during this planning effort. The purpose of the Proposed LUPA is to amend the Colorado River Valley, Grand Junction, Kremmling, Little Snake and White River BLM Resource Management Plans (RMPs) and the Routt National Forest Service Land and Resource Management Plan (LRMP) to identify and incorporate appropriate conservation measures to conserve, enhance and/or restore Greater Sage-Grouse habitat by reducing, eliminating, or minimizing threats to that habitat. The need for action is in response to the U.S. Fish and Wildlife Service's (USFWS) March 2010 "warranted, but precluded" Endangered Species Act listing petition. The USFWS found that the inadequacy of regulatory mechanisms was identified as a significant threat to GRSG in their finding on the petition to list the GRSG. Land use plan conservation measures were identified as the BLM's and Forest Service's principal regulatory mechanism.

This Proposed LUPA/FEIS has been developed in accordance with the National Environmental Policy Act of 1969, as amended, the Federal Land Policy and Management Act of 1976, as amended, and the National Forest Management Act of 1976, as amended. The Proposed LUPA is largely based on Alternative D, the preferred alternative in the Draft LUPA/DEIS, which was released on August 16, 2013. The Proposed LUPA/FEIS contains the Proposed Plan, a summary of changes made between the Draft LUPA/DEIS and Proposed LUPA/FEIS, impacts of the Proposed Plan, a summary of the written and verbal comments received during the public review period for the Draft LUPA/DEIS, and responses to the comments.

In accordance with 36 C.F.R. § 219.59, the Forest Service will waive their objection procedures of this subpart and instead adopt the BLM's protest procedures outlined in 43 C.F.R. §1610.5-2.

Pursuant to BLM's planning regulations at 43 C.F.R. 1610.5-2, any person who participated in the planning process for this Proposed LUPA and has an interest that is or may be adversely affected by the planning decisions may protest approval of the planning decisions within 30 days from date the Environmental Protection Agency (EPA) publishes the Notice of Availability of the FEIS in the Federal Register. For further information on filing a protest, please see the accompanying protest regulations in the pages that follow (labeled as Attachment # 1). The regulations specify the required elements of your protest. Take care to document all relevant facts. As much as possible, reference or cite the planning documents or available planning records (e.g., meeting minutes or summaries, correspondence, etc.).

Emailed protests will not be accepted as valid protests unless the protesting party also provides the original letter by either regular mail or overnight delivery postmarked by the close of the protest period. Under these conditions, the BLM will consider the emailed protest as an advance copy and will afford it full consideration. Before including your address, phone number, email address, or other personal identifying information in your protest, be advised that your entire protest – including your personal identifying information – may be made publicly available at any time. While you can ask us in your protest to withhold from public review your personal identifying information, we cannot guarantee that we will be able to do so.

The BLM Director, in agreement with the responsible official for the U.S. Forest Service (USFS), will make every attempt to promptly render a decision on each protest. The decision will be in writing and will be sent to the protesting party by certified mail, return receipt requested. The decision of the BLM Director shall be the final decision of the Department of the Interior on each protest. Responses to protest issues will be compiled and formalized in a Director's Protest Resolution Report made available following issuance of the decisions.

Upon resolution of all land use plan amendment protests, the BLM and USFS will issue an Approved LUPA and Record of Decision (ROD). The Approved LUPA and ROD will be mailed or made available electronically to all who participated in the planning process and will be available on the BLM website at <https://www.blm.gov/epl-front-office/eplanning/planAndProjectSite.do?methodName=dispatchToPatternPage&currentPageId=48133> and the USFS website at <http://www.fs.usda.gov/mbr>.

## **Protest Regulations**

[CITE: 43C.F.R.1610.5-2]

TITLE 43--PUBLIC LANDS: INTERIOR  
CHAPTER II--BUREAU OF LAND MANAGEMENT, DEPARTMENT OF THE INTERIOR  
PART 1600--PLANNING, PROGRAMMING, BUDGETING--Table of Contents  
Subpart 1610--Resource Management Planning  
Sec. 1610.5-2 Protest procedures.

- (a) Any person who participated in the planning process and has an interest that is or may be adversely affected by the approval or amendment of a resource management plan may protest such approval or amendment. A protest may raise only those issues that were submitted for the record during the planning process.
  - (1) The protest shall be in writing and shall be filed with the Director. The protest shall be filed within 30 days of the date the Environmental Protection Agency published the notice of receipt of the final environmental impact statement containing the plan or amendment in the Federal Register. For an amendment not requiring the preparation of an environmental impact statement, the protest shall be filed within 30 days of the publication of the notice of its effective date.
  - (2) The protest shall contain:
    - (i) The name, mailing address, telephone number and interest of the person filing the protest;
    - (ii) A statement of the issue or issues being protested;
    - (iii) A statement of the part or parts of the plan or amendment being protested;
    - (iv) A copy of all documents addressing the issue or issues that were submitted during the planning process by the protesting party or an indication of the date the issue or issues were discussed for the record; and
    - (v) A concise statement explaining why the State Director's decision is believed to be wrong.
  - (3) The Director shall promptly render a decision on the protest.
