The east boundary is the power line ROW and Wilderness Boundary roads on all remaining sides. This portion of the unit was split off during field review of the unit.

The north and northeast boundary are roads with the east based on private land and the south east based on the power line ROW. The majority of the south boundary is based on private land with the west boundary based on the power line ROW.
