The initial inventory boundary was delineated through a GIS exercise based on roads, land ownership and Rights of Way. The road data were digitized by AGRC using ARC/Info from USGS 7.5 Minute quadrangle maps. Roads with codes (1-4, 1 Primary Route, 2 Secondary Route, 3 Primary Road and 4 Secondary Road) were used initially as wilderness inventory roads and field verified during the inventory process to determine if they met the FLPMA definition of a road. The NE Boundary is the B-16 road. The southern boundary is the D-743/L105232 road. The western boundary is the D-1240/L105231 road. The northern boundary is a main bladed road in Nevada

The unit is comprised of BLM land with two state sections within it. The unit is located 35 miles north of Modena in Hamlin valley along the Utah/Nevada border. The topography is made up of a dry valley bottom with no topography, some upland bench, sage, grasses, pinion and juniper, grazing operations with range improvements.
