Project Description: The Nevada Department of Wildlife intends to release approximately 15-20 desert bighorn sheep in order to augment an existing herd within the Excelsior Mountains. There is adequate water, forage, and escape cover near the release site and in the mountain range support these additional sheep. There are no conflicts with domestic sheep grazing in the Excelsior Mountains. The sheep are gathered by NDOW at an appropriate area elsewhere and are brought to the release site in a trailer using established roads (See Map 1). The release will occur sometime after late September 2011.
