**A. Background**

BLM Office: Shoshone Field Office. Lease/Serial/Case File No.: N/A

Proposed Action Title/Type: Star Lake Cattle Guards (East Star Lake/Camp II C.G. & Owinza RR Crossing C.G.)

Location of Proposed Action: T.7S, R. 19E, Section 14, SE4SW4; T.6S, R. 20E, Section 15, NW4SE4.

Description of Proposed Action: Install two cattle guards; East Star Lake/Camp II cattle guard on a BLM maintained road in an existing pasture boundary fence and Owinza RR Crossing cattle guard on a county road in an allotment boundary and railroad right of way fence. The installation would require the digging of a shallow pit in the existing road bed and placing metal grates on precast concrete bases. In most cases the area disturbed during installation would be less than .01 acre per cattle guard. The project would also incorporate an additional gate to one side where livestock, wide loads and metal tracked equipment could pass. Occasionally, minor additional excavation would be needed to provide for adequate drainage and maintenance.

\_\_\_yes\_ The proposed action is in conformance with the LUP, even though it is not specifically provided for, because it is clearly consistent with the following LUP decision(s) (objectives, terms, and conditions): The proposed action is in conformance with the *Range Improvements, Structural Improvements* section, page 37 of the Monument RMP. The Monument RMP states; "Where fences cross existing roads, cattle guards or gates would be installed." In the *Rationale For Selection Of The Proposed Monument RMP* section on page 47 it states under *Livestock Grazing and Range Improvements*: "Additional range improvements, wells, pipelines, roads and fences would be provided" and "Range improvements would be designed to enhance, or to have few adverse impacts on the other resource uses." The proposed cattle guards are not only essential to maintain convenient

public access but also serve the public safety and maintain the integrity of grazing management plans.

**C. Compliance with NEPA:**

The Proposed Action is categorically excluded from further documentation under the National Environmental Policy Act (NEPA) in accordance with 516 DM 11.9, G #2, Appendix 4-153. “Installation of routine signs, markers, culverts, ditches, water-bars, gates, or **cattle guards** on/or adjacent to roads and trails identified in any land use or transportation plan, or eligible for incorporation in such plan.”

This categorical exclusion is appropriate in this situation because there are no extraordinary circumstances potentially having effects that may significantly affect the environment. The proposed action has been reviewed, and none of the extraordinary circumstances described in 43 CFR 46.215 apply. Attached is the Categorical Exclusion Review Sheet, Consideration of Extraordinary Circumstances.





# STAR LAKE CATTLEGUARDS
