Project Description: NASTR has submitted a five year permit renewal to conduct an annual horse endurance ride in the north end of the Pinenut Range. NASTR previously operated this event under a five year permit and maintained a good record of permit compliance. The one day event is typically held in late May or early June. This year the proposed event date is scheduled for May 27, 2012. Endurance courses are generally 25-50 miles long with a combination of various loops that accumulate the ride mileage. The proposed event would utilize approximately 56 miles of established routes. Routes proposed are primarily on dirt roads; there is at least one trail segment near Bull Run Spring about 2.5 miles long. Of the estimated 56 miles of proposed course, approximately 12 percent is located on private land. Up to 8 combination water stop / check point stations would be used along the proposed course. Water stops would utilize portable 50 gallon "Rubbermaid" type tanks stationed along the course (see map). Course loops are flagged in different colors and directional arrows are drawn using white flour on the ground. Flagging is removed immediately following the event. All camping, parking and the start/finish would be located at the Dayton Valley Rodeo Grounds; lands managed by the BLM under an R&PP lease with Lyon County. The event typically draws 50 - 100 participants and up to 30 additional people associated with the event (i.e. club members, spectators).


