**A. Background**

**BLM Office:** Kingman Field Office

**Lease/Serial/Case File No.:** N/A

**Proposed Action Title/Type:** Backfills of abandoned mine workings

**Locations of Proposed Action:** Public lands managed by Bureau of Land Management, Kingman Field Office (KFO).

**Description of Proposed Action** BLM would backfill abandoned mine shafts on public land in KFO for fiscal years 2013-2015. These abandoned mine workings have been surveyed by Arizona Game and Fish Department wildlife biologists, who recommended that they be permanently closed because of their lack of value as bat habitat. Backfilling these dangerous abandoned mine workings will prevent accidental falls and contamination of soil and groundwater by dumping of hazardous materials. All mining claimants with claims in the area have been notified of this work. No objections to the closures were received by BLM, Kingman Field Office. If owls are found in any workings, they will be expelled with smoke bombs or flares before backfilling. Access roads may require minor maintenance with no new disturbance – the footprint of any access roads will not be expanded. Access roads will be returned to their original condition after the closures are completed, by restricting or blocking traffic.

### **C: Compliance with NEPA:**

The Proposed Action is categorically excluded from further documentation under the National Environmental Policy Act (NEPA) in accordance with 516 DM 11.9, Appendix 4, J (8) – Installation of minor devices to protect human life, (e.g., grates across mines), and, Appendix 4, J (10) -- Removal of structures and materials of no historical value, such as abandoned automobiles, fences, and buildings, including those built in trespass and reclamation of the site when little or no surface disturbance is involved.


This categorical exclusion is appropriate in this situation because there are no extraordinary circumstances potentially having effects that may significantly affect the environment. The proposed action has been reviewed, and none of the extraordinary circumstances described in 516 DM2 apply.

I considered the following when reviewing the proposed project:

- Backfilling abandoned mine workings will have a positive effect on public health & safety. Accidental injury or death due to falls into the openings will be eliminated. Contamination of soil and groundwater by the dumping of hazardous materials into abandoned mine shafts will be prevented.
- Mining claimants have been notified of the proposed backfills, and no objections were made.
- Disturbance will be limited to the minimum necessary to backfill the holes. Material for backfilling will come from waste rock dumps only.
- Cultural clearances have been completed for the sites. No historic features would be impacted by the proposed backfilling. Standard stipulations apply.
- No T&E habitat or species are present in this area, and there is no significant bat habitat in the shafts to be backfilled, according to wildlife surveys completed by biologists from the Arizona Game & Fish Dept. (AZGFD), who recommended that all sites could be backfilled without first installing wildlife exclusions.

**Project Description:** BLM would backfill abandoned mine workings located on public land in T. 22 N., R. 18 W.; T. 23 N., R. 18 W.; T. 24 N., R. 18 W., near Chloride, Arizona. BLM would use a backhoe or bulldozer to push material from the waste rock dumps next to the features into the holes. Backfilling these abandoned mine workings would significantly improve public safety, as the physical safety hazards would be permanently eliminated. It would prevent the dumping of hazardous materials into the holes, protecting soil and groundwater from contamination. Cultural and biological surveys have been completed. Arizona Game and Fish Department surveys show that these abandoned mine workings provide minimal or no habitat for bats. Some workings will be cleared of bats before backfilling. If owls are found in any mine workings, they will be expelled with smoke bombs or flares before backfilling.

**Decision:** Based on a review of the project described above and field office staff recommendations, I have determined that the project is in conformance with the land use plan and is categorically excluded from further environmental analysis. It is my decision to approve the action as proposed.
