Project Description: Mick Casey is requesting a negotiated sale contract for 200 cubic yards of sand and gravel borrow material from an existing gravel pit. This material contract, pursuant to 43 CFR §3600, will authorize Mick Casey to excavate and remove the borrow material from the existing pit. The site is not in a riparian area. Access is via existing two track road. The Pit location is along Dixie Valley Road about a half mile NW of the Settlement Road turn off. Reclamation will occur at the completion of the contract.


