
Proposed Action Title/Type: Access to weather stations in the NPR-A

Description of Proposed Action:

ConocoPhillips Alaska, Inc. (CPAI) has requested approval to access weather stations (ARGSW1, ARGSE2, ARGNE2, and ARGNW1) in the National Petroleum Reserve Alaska (NPR-A). ARGNW1 and ARGNE2 are located on land that has been transferred to Kuukpik Corporation. The Bureau of Land Management (BLM) does not authorize use on private lands therefore we would only grant access to ARGSW1 and ARGSE2. This may require several trips between March 10th and breakup (late April/early May). Winter access is preferred as they would be accessible via rolligon. Access in the summer would require a helicopter which would be costly and create a greater impact to the community. Access to the sites would be from this winter's established snow trail or ice road. Access to ARGSW1 and ARGSE2 is approximately 6.6 miles west of the Peak Rolligon trail from DS-2P to the Cassin Midway Camp. Access is needed to perform operations and maintenance activities. Time spent at each location would be less than a day and any overnight stay would be at an already approved site.
