The Bureau of Land Management (BLM) has prepared an environmental assessment to evaluate the environmental effects of the BLM proposal, Tom Springs and Bryce Allotments Grazing Permit Renewals, on lands administered by the Safford Field Office; and is now releasing for public comment the Environmental Assessment (EA) and Standards and Guidelines Evaluations.

The EA describes the affected environment and discusses potential impacts of the project on the human environment. Issues and concerns expressed by BLM Staff and the public during the public scoping period for this allotment have been considered in the analysis.
