Project Description: The cinderblock building on concrete slab near the East Yellowjacket Historical Site constitutes an attractive nuisance and has been subject to past occupancy/trespass situations most recently resulting in federal court appearances by BLM Law Enforcement and resource specialists. Since that time BLM has implemented regular patrols by law enforcement as well as access restrictions and signage which require regular maintenance by resource personnel. The East Yellowjacket site is situated along the V&T Railroad route and is observed by hundreds of visitors annually. Over the years an abundance of solid waste has accumulated on site and cultural resources have been damaged. Attempts to contact the operator and claim owner have come up empty. This structure was built in the pre-bonding era of the 3809 regulations therefore we have no bond monies to utilize for this remediation. The Nevada State Office BLM has awarded funding for the removal of this nuisance structure for the purpose of human health and safety risks associated with an abandoned building in Storey County. During this proposed action should any cultural resources be uncovered, the project would be discontinued and appropriate measures taken to ensure that all cultural resources are protected. All material would be transported and disposed of off-site. Implementation may occur summer 2013.



APPEAL PROCEDURES

This decision may be appealed to the Interior Board of Land Appeals, Office of the Secretary, in accordance with 43 CFR Part 4. If you appeal, your appeal **must also** be filed with the Bureau of Land Management at the following address:

Your appeal must be filed within thirty (30) days from receipt or issuance of this decision. The appellant has the burden of showing that the decision appealed from is in error.

If you wish to file a petition pursuant to regulation 43 CFR 4.21 (58 FR 4942, January 19, 1993) for a stay (suspension) of the decision during the time that your appeal is being reviewed by the Board, the petition for stay must accompany your notice of appeal. If you request a stay, you have the burden of proof to demonstrate that a stay should be granted. A petition for a stay is required to show sufficient justification based on the following standards:

1. The relative harm to the parties if the stay is granted or denied.
2. The likelihood of the appellants success on the merits.
3. The likelihood of immediate and irreparable harm if the stay is not granted.
4. Whether the public interest favors granting the stay.

The Office of Hearings and Appeals regulations do not provide for electronic filing of appeals, electronically filed appeals will therefore not be accepted.
