1. Description of the Proposed Action

XXX has submitted an application to renew his existing waterline rights-of-way (ROW) across Public Land. This ROW is used for domestic water to his home. The ROW was originally granted to Mr. XXX in 1982. The ROW is approximately 1000 feet long and 30 feet wide, diameter of pipe is 2 inches for a total of 0.690 acres, more or less. Mr. XXX has also submitted a copy of his Water Right License from the State of Idaho.

2. Location

Shoshone County, Idaho
Boise Meridian, T. 48 N., R. 4 E., section 22 lot 5.

3. Land Use Plan Conformance

In accordance with the Federal Land Policy and Management Act (FLPMA), this proposed action has been reviewed for conformance with the *Coeur d'Alene* Management Plan (RMP), approved *June 2007*. It is consistent with the following decisions from the RMP:

Goal LR-1 - Meet public needs for use authorizations such as right-of-way, leases, and permits when such needs are consistent with other resource values.

Objective LR-1-1 - Issue use authorizations consistent with other resources values.

Action LR-1.1.3 - To the extent possible, locate such authorized uses and applications for such uses where impacts on other resources will be the least disturbing.

4. Compliance with the National Environmental Policy Act (NEPA)

The proposed action is categorically excluded from further documentation under NEPA in accordance with *516 DM 11.9.E(9) Renewals and assignments of leases, permits, or rights-of-way where no additional rights are conveyed beyond those granted by the original authorizations. Application of this categorical exclusion is appropriate in this situation because there are no extraordinary circumstances having effects that may significantly affect the*

environment. The proposed action has been reviewed, and none of the extraordinary circumstances described in 516 DM 2, Appendix C, exist.




