Project Name: Road and Highway Army Pit Airport Project

Project Description: Road and Highway Builders, LLC (RHB) is requesting a negotiated sale contract for 20,500 tons of sand and gravel material from an existing army pit north of Hawthorne. The material will be used to make material for Hawthorne Airport project contract No. 3-32-0009-11. The material will be crushed and processed onsite into the required material for the contract. RHB will mobilize a portable crushing spread, hot plant and truck scale. The crushing material is anticipated starting in September 2013.

This material sale contract, pursuant to 43 CFR §3600, will authorize Road and Highway Builders, LLC to excavate and remove the sand and gravel material from the existing pit. Final reclamation will be achieved by re-contouring all slopes to a safe and stable angle close to original topography. The pit location is not within a riparian area. The size of the project area is approximately 5.0 acre. The Army has given consent for the gravel sale and processing onsite.




