Description of Proposed Action: Coldwater Canyon Road is an existing road in T. 9 N., R. 2 E., sec 26 along the southern boundary of the AFNM. The road is paved and is approximately 2600 ft. in length and 33 ft. wide. It is the intention of the Monument to have this road serve as year round access for the Monument as well as the general public. The road was in existence when the lands were acquired from the State of Arizona but was never mentioned in the final clear list. The R/W would be issued in perpetuity.
