To: Parties interested in Spar Canyon-Round Valley Access Road System Improvements

Bonneville Power Administration (BPA) proposes to improve the access road system for its existing Spar Canyon–Round Valley transmission line located on Bureau of Land Management (BLM) land in Custer County, Idaho (map enclosed). BPA and BLM plan to jointly prepare an environmental assessment (EA) for the proposal. This letter provides an overview of BPA’s proposal, outlines the environmental review process and schedule, and invites you to comment.

Proposal – BPA’s system improvements would involve constructing 4 to 6 miles of new road, reinforcing road crossings at drainages with rock, and acquiring access rights from BLM for new road use. These improvements are needed because existing roads are in poor condition or lack a defined route of travel. Access roads are critical for continued safe and reliable operation and maintenance of the power transmission system.

BPA submitted an application to the BLM Challis Field Office on September 18, 2013 to amend the existing BLM right-of-way, serial number IDI-22582, for the proposed access road system improvements. BPA and BLM will prepare an EA to understand the potential impacts of the proposal and identify ways to avoid, minimize, and mitigate those impacts.

The following preliminary issues and potential impacts were identified through internal scoping: priority Sage Grouse habitat, visual resource management, and inclusion of the proposed access roads in the Challis travel management plan.

Public involvement – Please let us know if you have concerns about particular resources or questions about the project. Our agencies will consider information we receive to help develop the EA. 
