CATEGORICAL EXCLUSION /PLAN CONFORMANCE DOCUMENTATION AND DECISION For Long Term Campsite SF 3.9L

A Background

Proposed Action: Renewable Minimum Impact Land Use Permit (43 CFR 2920.06)

Date of Proposed Action: May 1, 2015 through April 30, 2018

Description of Proposed Action:

Dan Ranberger submitted an application requesting a Long-Term Campsite (LTC) on the Main Stem of the Fortymile River. The site is located at the confluence of the North and South Fork River. The site is an improved LTC and has been used in the past by suction dredge miners for camping to support their state riverbed mining operations.

The site is described as NW1/4/NW1/4, Sec.12 T26N. R18E (SF 3.9L) on the South Fork.

The applicant will use the site for camping and equipment storage. They will have a tent for cooking, tents for sleeping, a pit toilet, and a pit cooler. Access will be by watercraft from the South Fork River Bridge. This site has been analyzed in EA-AK-080-88-010 and no additional impacts are anticipated.

B. Land Use Plan Conformance

This proposed action has been determined to be in conformance with the following land use plans:

- Fortymile River Management Plan
Date Approved/Amended: 10/11/1983.

The proposed action is in conformance with item 6 (pp.49-50) "Long term camping in the river corridor will be authorized by permit. Camping will be subject to such provisions as necessary to protect scenic, recreational, fish and wildlife and other values of the river area".

- Land Use Plan Name: Fortymile Management Framework Plan
Date Approved/Amended: 9/08/1980.

The proposed action is in conformance with the LUP, even though it is not specifically provided for, because it is clearly consistent with the following LUP objective under Lands-(1), "Make lands available for intensive use and public purposes".

C. Compliance with NEPA:

This proposed action qualifies as a categorical exclusion under 516 Departmental Manual (DM), 11.9, Appendix 4, E (16), BLM Handbook H-1790-1, which states "Acquisition of easements for an existing road or issuance of leases, permits, or rights-of-way for the use of existing facilities, improvements, or sites for the same or similar purposes". None of the exceptions in 516 DM Chapter 2, Appendix 2, apply, as reviewed here:

Decision

It is my decision to approve the occupancy of an existing Long-Term Campsite(s), subject to existing Terms and Stipulations in the Environmental Assessment, EA No. AK-080-88-010, (see exhibit G) and the attached Special Stipulations (See Exhibits E)


The minimum rental established by Instructional Memorandum AK-2005-028 should be applied. Therefore rent for this proposed activity shall be \$250.

Rationale

1. This action implements Action 6.1 of the Fortymile River Management Plan.
2. Authorizing Long-Term Campsites to suction dredge miners within the river corridor reduces the impacts by having the miners camp above the ordinary high water mark, out of sight to other river users.
3. There are no anticipated impacts to cultural resources.
4. The Proposed Action will not significantly restrict subsistence uses.
5. The proposed action would not impact salmon or habitat known to support salmon and therefore, the proposed action was assigned the EFH determination: *No effect*, and no further EFH consultation is required.

Appeal Procedures

This decision may be appealed to the Interior Board of Land Appeals, Office of Hearings and Appeals ,in accordance with 43 CFR Part 4 and DOI Form 1842-1. The notice of appeal must be filed in the Bureau of Land Management Eastern Interior Field Office (at the above address) within 30 days from receipt of this decision.




