It is the responsibility of the Applicant/Operator to see that all stakes, flagging, posts or other materials placed on the locations and/or access roads, pipelines and associated rights-of-way are removed.

Under regulations addressed in 43 CFR 3165, you have the right to appeal this decision. An informal review of the technical or procedural aspects of the order may be requested of this

office before initiating a formal review request. As an Operator, you have the right to request a State Director review of this order. You must request a State Director review prior to filing an appeal to the Interior Board of Land Appeals (IBLA) (43CFR 3165.4).

If you elect to request a State Director Review, the request must be received by the Wyoming State Office Post Office Box 1828, Cheyenne, Wyoming 82003, no later than 20 business days after receipt of this letter. The request must include all supporting documentation unless a request is made for an extension of the filing of supporting documentation. For good cause, such extensions may be granted. You also have the right to appeal the decision issued by the State Director to the IBLA.
