### INFORMATION NOTICE

The following information applies to ALL parcels on the WY-202Q June 23-24, 2020, *Notice of Competitive Oil and Gas Lease Sale*, and the WY-203Q September 22-25, 2020, *Notice of Competitive Oil and Gas Lease Sale*, with the exception of 8 parcels.

On May 22, 2020, the U.S. District Court for the District of Montana, Great Falls Division issued a decision in the case of Montana Wildlife Federation, et al. vs. Zinke (4:18-cv-00069-BMM). The decision vacated BLM Instruction Memorandum (IM) 2018-026 ("Implementation of Greater Sage-Grouse Resource Management Plan Revisions or Amendments – Oil & Gas Leasing and Development Prioritization Objective"). The BLM Wyoming is in the process of developing a strategy which will meet the leasing prioritization management requirement set forth in the 2015 Greater Sage-Grouse land management plan revisions and amendments.

Pending finalization and implementation of a leasing prioritization strategy, the BLM Wyoming State Director has deferred sale of oil and gas lease sale parcels located in Greater Sage-Grouse habitat management areas. For that reason, all parcels listed in the posted Notice of Competitive Oil and Gas Lease Sale, September 22-25, 2020 are deferred from sale, with the exception of the following 8 parcels (:
