**INFORMATION NOTICE**

The *Notice of Competitive Oil and Gas Lease Sale* dated April 18, 2022, for the June 21-22, 2022 lease sale, is being amended to update the sale date. The BLM Wyoming parcels will now be offered on **June 22-23, 2022**, on EnergyNet.com. Please visit their website for details.

The sale parcels will open and close over two days. Bidding starts on **June 22, 2022**, at 07:30 a.m. Mountain Standard Time (MST) / 8:30 a.m. Central Standard Time (CST). All bidding will conclude on **June 23, 2022**.

105 parcels (WY-2022-06-1612 through WY-2022-06-1227) will open at 2-minute intervals with a total bidding time of 1 hour on **Wednesday, June 22, 2022**, starting at 7:30 a.m. MST / 8:30 a.m. CST.

24 parcels (WY-2022-06-6976 through WY-2022-06-7214) will open at 2-minute intervals with a total bidding time of 1 hour on **Thursday, June 23, 2022**, starting at 7:30 a.m. MST / 8:30 a.m. CST.

If your bonus bid was more than \$2 per acre or fraction of an acre and you do not pay the full amount on the day of the sale for the parcel, you must pay any balance due by the close of business on the 10th working day after the last day of the internet-based auction closes. Remaining balance will be due in the Wyoming State Office by 4:00 p.m. Mountain Standard Time, **July 8, 2022**. If you do not pay in full by this date, you lose the right to the lease and all money paid the day of the sale. If you forfeit a parcel, it may be offered again at a future sale.
