BLM - Pat Deibert: Those plan amendments affected the states listed there - California, Colorado, Idaho, Montana, Nevada, North and South Dakota, Oregon, Utah, and Wyoming, and

BLM - Pat Deibert: to become more consistent with the state planning efforts and to look at balancing some of our more, our land use efforts within the BLM itself.

BLM - Pat Deibert: Only the States listed there chose to have their plans amended. Montana, and the Dakotas were content with the

BLM - Pat Deibert: litigation ensued and the courts, then enjoyed the BLM from implementing the amendments, asking us to go back to 2015 amendments until we could resolve some of the issues that the plaintiffs addressed in their initial complaint.

BLM - Pat Deibert: There's been a lot of new information that has been issued even in this past year and the BLM wants to make sure we're being very thorough, including science in our decision process.

BLM - Pat Deibert: This is our planning area and it encompasses all the states, including those states who chose not to participate in the 2019 decision or amendments, so it covers all the states that we have previously identified.

BLM - Pat Deibert: So these are some of the preliminary issues and I'm not going to spend a great deal of time going into detail on these issues because that information is provided in our notice of intent.

BLM - Pat Deibert: So they include the identification, management, and conservation of these important greater sage-grouse and sagebrush habitat, also known as sagebrush focal areas, that were identified in 2015.

BLM - Pat Deibert: And went into a planning effort with BLM in 2016 and that was to withdraw mineral entry from those areas.

BLM - Pat Deibert: They also include how we are going to be deal greater sage-grouse habitat management areas. So many of these management areas because of the new science has come out

BLM - Pat Deibert: have changed from where they were originally delineated. We want to know how we can work within those management areas, how we can adapt as those areas continue to evolve as the size emerges, and how we can address non-habitat that are included in some of those things.

BLM - Pat Deibert: We also want to look at habitat objectives for the greater sage-grouse including how those objectives might be altered, then the consideration of climate change effects, especially when you think about things like drought.

BLM - Pat Deibert: We will be looking at the application, the mitigation hierarchy, that is, avoid, minimize, and mitigate

necessary, so we will be including consideration of compensatory mitigation.

BLM - Pat Deibert: We will be looking at approaches to minimize disturbance to greater sage-grouse and to the sagebrush habitats which will also include a review of disturbance and density caps and the buffers have been included in previous planning efforts.

BLM - Pat Deibert: We're going to be looking at leasing and development of mineral resources within greater sage-grouse and other sagebrush habitats.

BLM - Pat Deibert: We're also going to be looking at the leasing and development of renewable energy resources in greater sage-grouse and sagebrush habitats, including the associated transmission lines.

BLM - Pat Deibert: Management of livestock grazing and wild horse and burro populations is also going to be important to this planning effort. We want to look at the potential impact of that management on greater sage-grouse and sage-grouse habitats.

BLM - Pat Deibert: And then we also want to look at strategies for greater sage-grouse and sage-grouse habitat restoration, but we also want to avoid any unintended consequences to other species, we don't want to do conservation for one species, only to result in a negative situation for another species.

BLM - Pat Deibert: We're going to look at a process of how to adapt management of greater sage-grouse habitats and sagebrush habitats in response to the habitat loss and the ongoing populations declines that we are now seeing.

BLM - Pat Deibert: And perhaps the biggest issue that we're going to be struggling with here is to take a look at the role of wildland fire and invasive species management and greater sage-grouse and sagebrush habitats.

BLM - Pat Deibert: And how planning can, or perhaps may not be very useful, in addressing that issue, but we will be discussing it through our planning efforts.
