WYScoping-1-500805457	The vast majority of the public values migration corridor designation and knowing that federal and state agencies respect what has been put in place to protect wildlife resources. I respectfully request that you remove large swaths of lease parcels that have important wildlife corridor features.
WYScoping-1-500805458	<p>Proposed oil and gas leases affect all three of Wyoming's protected wildlife migration corridors, as well as others on their way to protected status. These corridors are vital to the survival of mule deer and pronghorn populations that people depend on for hunting, wildlife viewing and traditional uses. Alternative leasing locations should be considered that do not interrupt migration routes these species have relied on for millennia.</p> <p>Oil and gas drilling further threatens wildlife by driving changes in climate that negatively affect their habitats and populations. Rather than offering new oil and gas leases, advancing carefully-sited renewable energy development on public lands that <u>minimize wildlife impacts promises a healthier, more prosperous future for people and nature.</u></p>

WYScoping-1-500805468	<p>As a 45 + year Wyoming resident and wildlife advocate, I find the idea of offering for lease land parcels that were clearly designated as off limits to be extremely troubling. The identified Sublette Pronghorn Migration Corridor is intersected by 31 parcels totaling 49,329 acres that the BLM is proposing to auction during a June 2026 oil and gas lease sale. Why? Over 280,000 acres of the so-called Golden Triangle, home to the densest population of sage grouse left on Earth — is designated as an “area of critical environmental concern,” excluded from surface-disturbing activities and expressly closed to mineral leasing. Although the Rock Springs area resource management plan may not be popular with Wyoming leaders or oil companies, it is the plan that was signed off on last December and should be followed.</p> <p>Protecting pronghorn, mule deer, and critical sage grouse habitat is a priority that BLM is required to take seriously. Research has shown that disturbance through drilling activities profoundly and negatively impacts these species. BLM needs to change course and remove the parcels within the designated Golden Triangle area.</p>

The herd has already suffered a significant decline (up to 40% in recent years).</p> <p>Scientific Impact: Peer-reviewed studies confirm that oil and gas development is a driver of long-term pronghorn population decline and reduced productivity (fawn survival). Pronghorn avoid infrastructure, which leads to functional habitat loss and fragmentation.</p> <p>Migration Blockage: Leasing this area, particularly within known migration bottlenecks, risks severing this ancient, critical pathway entirely. Once this migration memory is lost due to an insurmountable barrier, it may not be regained.</p> <p>The long-term ecological and economic value of this iconic wildlife resource, which supports Wyoming's hunting and tourism, far outweighs the short-term revenue from this lease sale. Please prioritize conservation and say NO to the proposed auction.</p>

WYScoping-1-500805472	<p>To whom it may concern,</p> <p>A federal auction scheduled for June proposes leasing tracts of all three protected Wyoming Pronghorn and deer migration corridors to oil and gas drilling, and it also opens the door to rigs within a now-unprotected pronghorn corridor that's eyed for protections of its own.</p> <p>The potential for industrial incursion into habitats that prized ungulate populations depend on to reach their seasonal ranges in the Platte, Little Snake and Green River basins comes via the Bureau of Land Management's lease sale of more than 250,000 acres in Wyoming. As of now what's being proposed is to auction more than five dozen parcels totaling 88,000 acres that overlap the state's first three deer migration corridors and its in-the-works pronghorn corridor.</p> <p>We can't lease and allow development in our big game migration corridors if we want our kids and grandkids to have the same hunting and wildlife viewing opportunities that we've enjoyed. In a state that has so many corridors and vast amounts of acres already opened to coal, oil, gas etc this region should be set aside for Wyoming's amazing migrations. My family and I will go out of our way to witness this amazing sight as we travel to another of Wyoming's treasures, Teton and Yellowstone National Park. There are very few pronghorn left near us in New Mexico because of the city encroachment and there moving around is hindered in all directions. I still remember seeing as a child driving through Wyoming the migrations we no longer have and wanting my children to witness what Wyoming was lucky enough to still have. Land for three of Wyoming's iconic species - mule deer, pronghorn, and sage grouse - should continue to be protected.</p> <p>Mule deer follow generations-old migration routes to a specific known wintering ground. They have places they take extended stops along their migration routes because they have preferred food at those stops. Oil and gas leasing brings more buildings, roads, fences, and human activity. Our own files show letters going back from the early 2000s up until the present, appealing to various authorities and agencies to reconsider ill-considered leasing plans that would affect migration corridors and habitat. The June 2026 proposed auction includes the Sublette Mule Deer Corridor (seven parcels totaling 13,749 acres, AKA, Red Desert to Hoback); the Platte Valley Mule Deer Corridor (three parcels totaling 4,293 acres); and 22 parcels totaling 20,685 acres in the Baggs Mule Deer Corridor. There are also 31 parcels totaling 49,329 acres in the Sublette Pronghorn Corridor, which has been identified by the Wyoming Game and Fish Department and is in the process of being assessed for designation by Wyoming's Gov. Mark Gordon. Significant overlap occurs in a disputed portion of the pronghorn corridor located east of Farson.</p> <p>The Wyoming Outdoor Council has also analyzed parcels in the lease sale that bisected migration routes mapped by the U.S. Geological Survey. There were 23 parcels totaling 29,775 acres that overlapped the Shirley Basin Pronghorn migration (12 parcels, 11,896 acres), Elk Mountain pronghorn migration (five parcels, 6,725 acres) and the Wyoming Range mule deer migration (six parcels, 11,154 acres).</p> <p>We understand that this proposed lease auction will triple the amount of acreage slated to be offered in December 2025 and March 2026. A representative of The Wilderness Society said federal land managers should pull back leases that are in the migration corridor. We strongly concur with that representative's statement: the BLM has a statutory obligation to inventory the migration routes and design management around them. "That has not happened for the vast majority of the corridors that are in this lease sale. The bottom line for us is allowing gas rigs and well pads in places where the migrating animals forage and rest puts those herds at risk."</p> <p>We urge you to give our concerns, and those of thousands of other citizens, your most serious and thoughtful consideration as you move forward with the proposed lease sales. Wyoming's wildlife and the future of that irreplaceable resource is at least as important as extracting oil and gas from the land. In our opinion, it's far more important.</p>

Having lived at Coyote Springs, a narrow passage along the corridor, I observed the migration in that location for 52 years beginning in 1966. Before the coming of Interstate 80, massive herds of deer, as many as 500 at a time, descended the Dana Ridge, crossed US 30 and the Union Pacific right-of-way, and proceeded on to wintering grounds. From our front window, we could observe the deer bounding down a steep cliff directly onto the roadway, a crossing out of view for approaching traffic. My efforts to have deer crossing signs installed required years of effort. Wyoming Game and fish tried several puny methods to facilitate the herds' crossing of the highway. For example, there was the motion detector with attached lighted signal, which was activated by snowflakes.</p> <p>The coming of I80 revealed that no thought had been given to wildlife migration corridors. Dead animals were on the roadside, live ones were crowding the fences, fences which were undergo several incarnations intended to solve the problem. After the October, 1970, opening of the Interstate, our migration dwindled to few individual animals, survivors.</p> <p>To paint a true picture of the migration route, you should highlight all the hazards on the corridor: first, the roadways, US 30 and I80, then the various fences along both. Impenetrable sheep fences remain long after the sheep are gone. During the bad winter of 2016, 4,000 antelope were enclosed on the triangle between the Elk Mountain road, I80, and US30 (by the game warden's count); escape brought them onto the highways; some survived. The RMP also identifies that more than 30,000 mule deer migrate through the ACEC with an average of 10,000 to 15,000 mule deer remaining for the winter. The Golden Triangle is nationally important, essential, for the conservation of both sage-grouse and mule deer.</p> <p>Tom Christianson, retired Wyoming Game and Fish Department Sage-Grouse Coordinator, who coined the name Golden Triangle, identified that the area supports the highest density of sage-grouse in Wyoming and rangewide (2/26/2019, WyoFile). These animals rely on migration routes to move in the state and a disruption can bring challenges for both animals and humans, most notably a possible search for different migration routes that could put the animal's lives in danger crossing roadways. Trapper's Point, a wildlife crossing for Wyoming's pronghorn, has shown significant success already with a large reduction in wildlife-vehicle crossings, however, the construction of such crossings is very expensive. I am a huge advocate for such wildlife crossings, both overpass and underpasses, but the millions of taxpayer dollars and need for private donations is what will be needed should tracts of land be open in Wyoming. In the past, highways and interstates have already been significant barriers for wildlife when it comes to crossing roads, and an increase in human activity will only further disrupt migration patterns that have been used for thousands of years.</p> <p>My main concern is especially towards the Greater Sage-Grouse and the disturbances to their habitat these leases could cause. These birds have already had significant declines in population numbers mostly due to human activity and invasive species encroaching on their habitat. To see parcels of land being open for sale so close to Greater Sage-Grouse leks, or breeding grounds, is particularly worrisome because these birds return to the same leks year after year. Like the pronghorn, deer, and elk, habitat disturbances will force these animals to find new areas for sustainable resources and that can bring them into contact with more people. North Dakota's Game and Fish Department has recently reported their Greater Sage-Grouse numbers have reached the point of extirpation unless there are migrations from neighboring states.</p> <p>Finally, the locations of these possible oil and gas parcels are a concern because of their proximity to water resources, notably the Fontenelle Reservoir that falls into the Green River, the Big Sandy River, Pass Creek and the Boysen Reservoir. Collectively, those parcels encompass 38,727 acres. There are seven parcels totaling 13,749 acres in the Sublette Mule Deer Corridor (AKA, Red Desert to Hoback), three parcels totaling 4,293 acres in the Platte Valley Mule Deer Corridor and 22 parcels totaling 20,685 acres in the Baggs Mule Deer Corridor.•In the 31 parcels, totaling 49,329 acres in the Sublette Pronghorn Corridor, which have been "identified" by the Wyoming Game and Fish Department and are in the process of being assessed for designation by Gov. Mark Gordon. Notably, significant overlap occurs in a portion of a well-known pronghorn antelope migration located east of Farson.•In the 23 parcels totaling 29,775 acres that overlapped the Shirley Basin Pronghorn migration (12 parcels, 11,896 acres), Elk Mountain pronghorn migration (five parcels, 6,725 acres) and the Wyoming Range mule deer migration (six parcels, 11,154 acres) that have been identified by the U.S. Geological Survey mapped migrations efforts undertaken by the Department of Interior efforts in association to carrying out Secretary Order 3362. <p>All of these parcels bisect known critical mule deer, pronghorn antelope, sage grouse habitat and important lek sites, as well as adversely affect overall habitat, migratory and landscape connectivity.</p> <p>The impacts of the proposed sales/leases and potential development to oil and gas extraction of over 60 parcels of Federal lands would be far reaching to these mule deer, pronghorn and sage grouse populations that are still recovering from the past discretions and impacts of sales/leases and oil and gas development as well as from the severe winter of 2022 and 2023. Of which Wyoming has lost a considerable portion (i.e. populace) of the mule deer and pronghorn herds identified above.</p> <p>I strongly recommend the Bureau of Land Management to designate all proposed administered lands (that are proposed to be for sale/lease) for consideration of back country conservation management, in consideration to:</p> <p>1)Protect, conserve, and enhance larger areas of generally intact and undeveloped BLM-managed lands that contain functional, unfragmented habitats, and migration/movement corridors for recreationally and economically important fish, and/or wildlife species, and;</p>

WYScoping-1-500805644	<p>Let's Not Destroy Our Wildlife Heritage with Irresponsible Development</p> <p>As a Wyoming native, hunter, and wildlife biologist who spent 32 years working for the Wyoming Game and Fish Department, I know that one of our state's greatest resources is our wildlife heritage. Our mule deer, elk, pronghorn, and sage-grouse populations are the envy of the world.</p> <p>That's not to say that some species don't face serious threats to their survival. The harsh winter of 2023 devastated pronghorn. And while we've had some promising lek counts for sage-grouse this year, overall sage-grouse numbers are still far too low. This is no time to be complacent and take our wildlife for granted.</p> <p>That's why I'm so concerned about provisions in the One Big Beautiful Bill Act (OBBBA) that passed earlier this year. It requires the Bureau of Land Management to lease large sections of land, which makes it more difficult for the agency to use its discretion to avoid leasing in sensitive wildlife areas. To see how disastrous this could be, we need look no further than the oil and gas lease sale proposed here in Wyoming for next June.</p> <p>It offers up 227 parcels totaling more than a quarter million acres. The parcels overlap with habitat for sage-grouse, including priority habitat; crucial winter habitat for elk, mule deer, and pronghorn; calving and fawning areas for elk, moose, and pronghorn; and mule deer migration corridors.</p> <p>Some 13-thousand of these acres overlap the famed Red Desert to Hoback mule deer migration corridor. Nearly 20,000 acres will be up for lease in the Golden Triangle, a place that has the highest sage-grouse density in the nation and features a pronghorn migration area currently being assessed for designation by Gov. Mark Gordon. Those impacts to wildlife were from the Jonah and Anticline Fields, and, while funds were expended, were impacts really mitigated. This is a good question to ask, especially in reference to the Sublette Mule Deer Herd (Hal Sawyer study) and in reference to the number of sage-grouse leks lost from these fields. Since these populations are, or were most likely linked to the current wildlife populations in the Red Desert, and, in particular, the Golden Triangle, efforts should be made to truly mitigate for those impacts. You need to examine the extent of those impacts prior to decimating the sage-grouse populations and severely impacting the Sublette Mule Deer Herd Unit further.</p> <p>Consideration should also be given to the current and past wildlife linkages to Yellowstone and Grand Teton National Parks. Pronghorn and mule deer are directly linked and elk were at one point, if not still, as elk collared along the Wind River Front Range have ended up being hunted and killed near Cody.</p> <p>Examine Hal Sawyer's study on the mule deer on the Anticline and use that information to determine really what we can/can't do relative to disturbance. Same goes for sage-grouse and the leks/populations that were lost because of these developments.</p> <p>Lastly, I'd suggest you go back to Range Management square one and really determine whether or not you are doing an adequate job. What percent of the Red Desert meets or exceeds BLM Range-related expectations and what are you doing about the remainder? You have all of the tools you need to do the job which places wildlife on equal footing with everything else, yet are failing to do so.</p> <p>I believe you need to call out the oil and gas industry and ensure that any jobs that are mentioned as a rationale for the further development be investigated thoroughly. I'm not sure that I believe the numbers that are given.</p> <p>Perhaps my 2 biggest concerns are sage-grouse and mule deer, however, these areas provide winter ranges for most of our ungulate populations as well. It would be nice if you could take existing data and "predict" the most likely outcome of the leasing and development.</p> <p>Thanks for allowing me to provide my concerns.</p>

Undefined	<p>I do not believe the Bureau can legally call the information available to the public now about the planned Q2 2026 lease offering "Scoping." The Bureau cannot expect the public to give it informed response about concerns when there is almost Zero information available other than a list of tracts proposed to be offered. To call this stage "scoping" defies the law. No matter what individuals claim, the law is not changed until both houses of Congress pass a bill to change it and the President signs that. I have led a campaign to change the Mineral Leasing Act which succeeded in 1987. This action does not comply with the law now.</p> <p>There are many examples in the CFR and in case law of Agency pretensions that NEPA had been complied with being overturned in court. I have been involved with several of those. The last time I challenged NEPA adequacy for a Bureau project, the Director of the Bureau pulled it and had an EIS prepared.</p> <p>For NEPA evaluation, context is important. The documents posted online for this only identify a list of tracts, No other information has been given to the public to see what the Bureau's range of options is, or the "affected environment." The only map I have seen - either from the Bureau or from conservation groups, shows the parcels proposed for Q2 2026 offering in isolation, as though there were no other leases in the area. This seems extremely improbable. What other leases are now in place around the proposed tracts? Is there activity on those leases? Has seismic work been done? Have APD's been applied for? Has drilling been done? Is there production? On what areas not leased have EOIs been filed? Can you show me where to find a map, or send me one - by the 16th, so I can make slightly informed comments? FedEx shipping charges can be billed to my account.</p>
	<p>I hope the Bureau has a standard, publicly available, GIS database that shows all leases current in the State of Wyoming, their owner, their term, any stipulations that apply, any permits granted or applied for, the operator, and any development and production. Does it? Can you direct me to that?</p> <p>The Texas Railroad Commission does have just this kind of GIS database. I was selling some minerals in the Delaware Basin seven years ago and found it very useful. An image of one area near Pecos, TX, is attached. Note the lines of horizontal drilling across several sections -- all, of course, under royalty agreement to resolve drainage disputes. Those boys are hard at work. Does the Bureau have a system comparable to this? At what online address can the public find this?</p> <p>What is the "Play" the EOIs east of Farson are hoping to succeed with? Where is geologic information on that published? What is the geologic theory? Where has that been published? Has the USGS evaluated it? Or, are the EOIs</p> <p>Thank you for your help. I believe this information should have been included in the Scoping Announcement in the first place. Since it was not, I hope you can help me now.</p>
